Pick-Up:

All badges and passes will be held in a “WILL CALL” envelope under your **COMPANY NAME** and will be available for pick-up as follows:

● ***Exhibitor Check-In Center during Set-up hours:***

Friday	November 14, 2008	8:00 am to 12:00 pm

● ***Will Call during the show:***

At **12:00pm** on Friday, November 14, 2008 all “WILL CALL” ENVELOPES will be moved to the **PUBLIC WILL CALL** located outside the show entrance.
